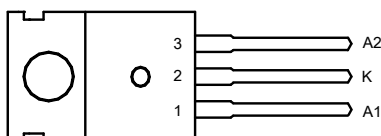

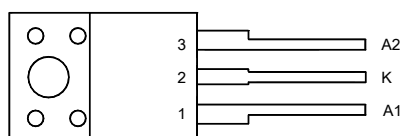

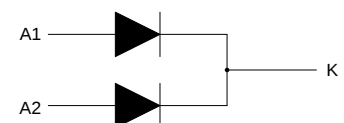

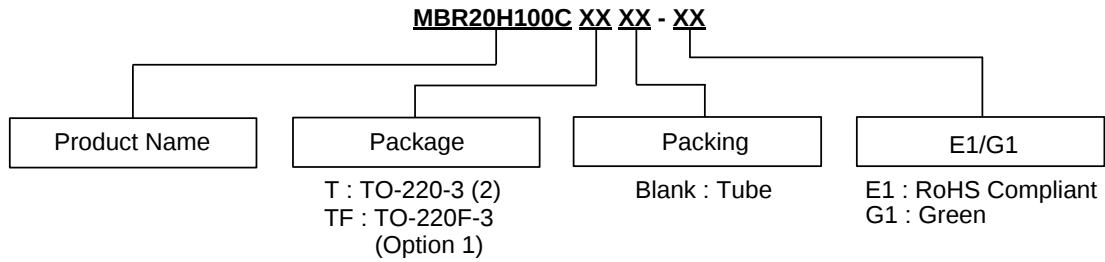


TO-220F-3 (Option 1)

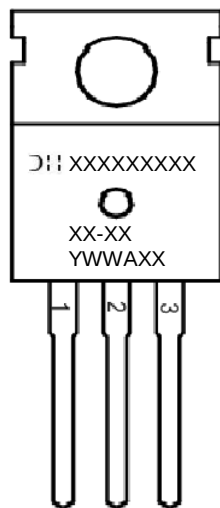

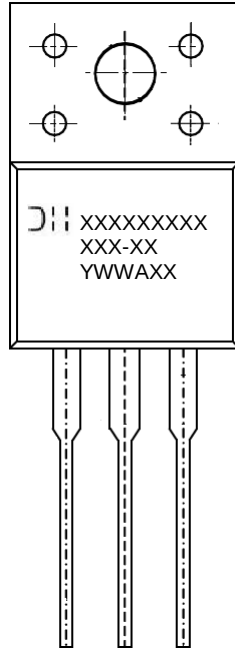

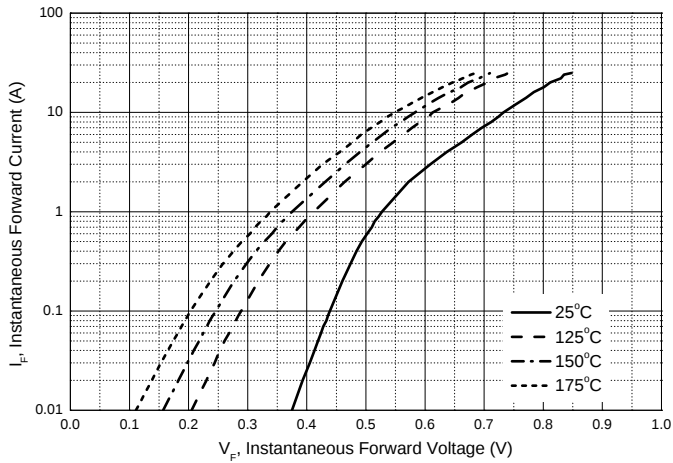


Figure 1. Typical Forward Voltage

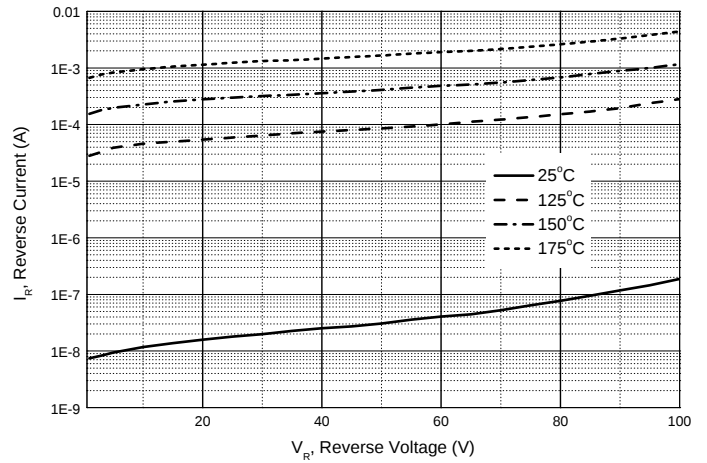


Figure 2. Typical Reverse Current

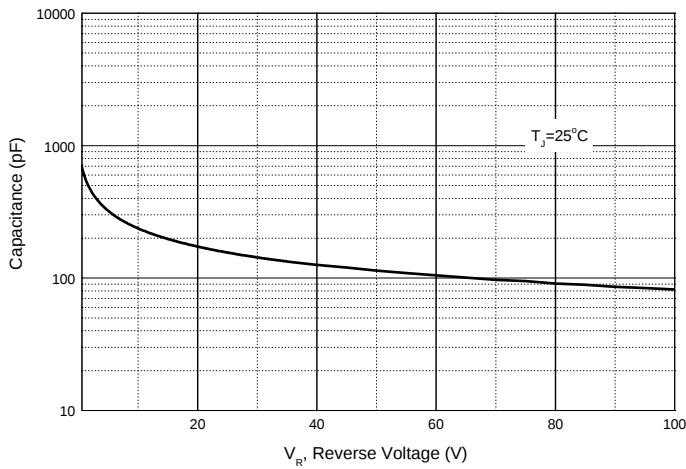


Figure 3. Capacitance vs. V_R , Reverse Voltage

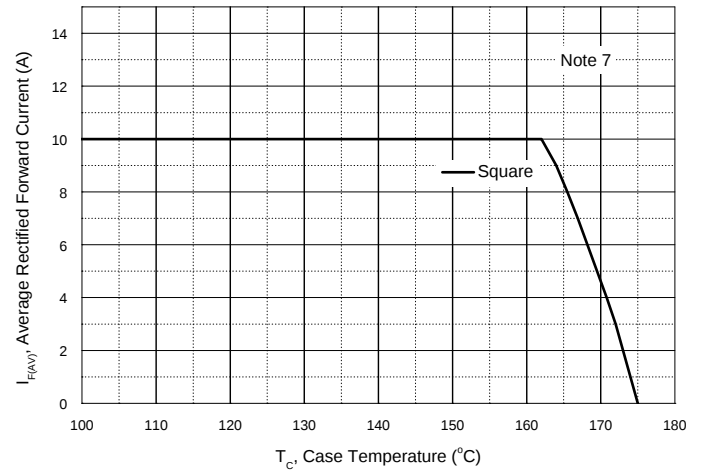
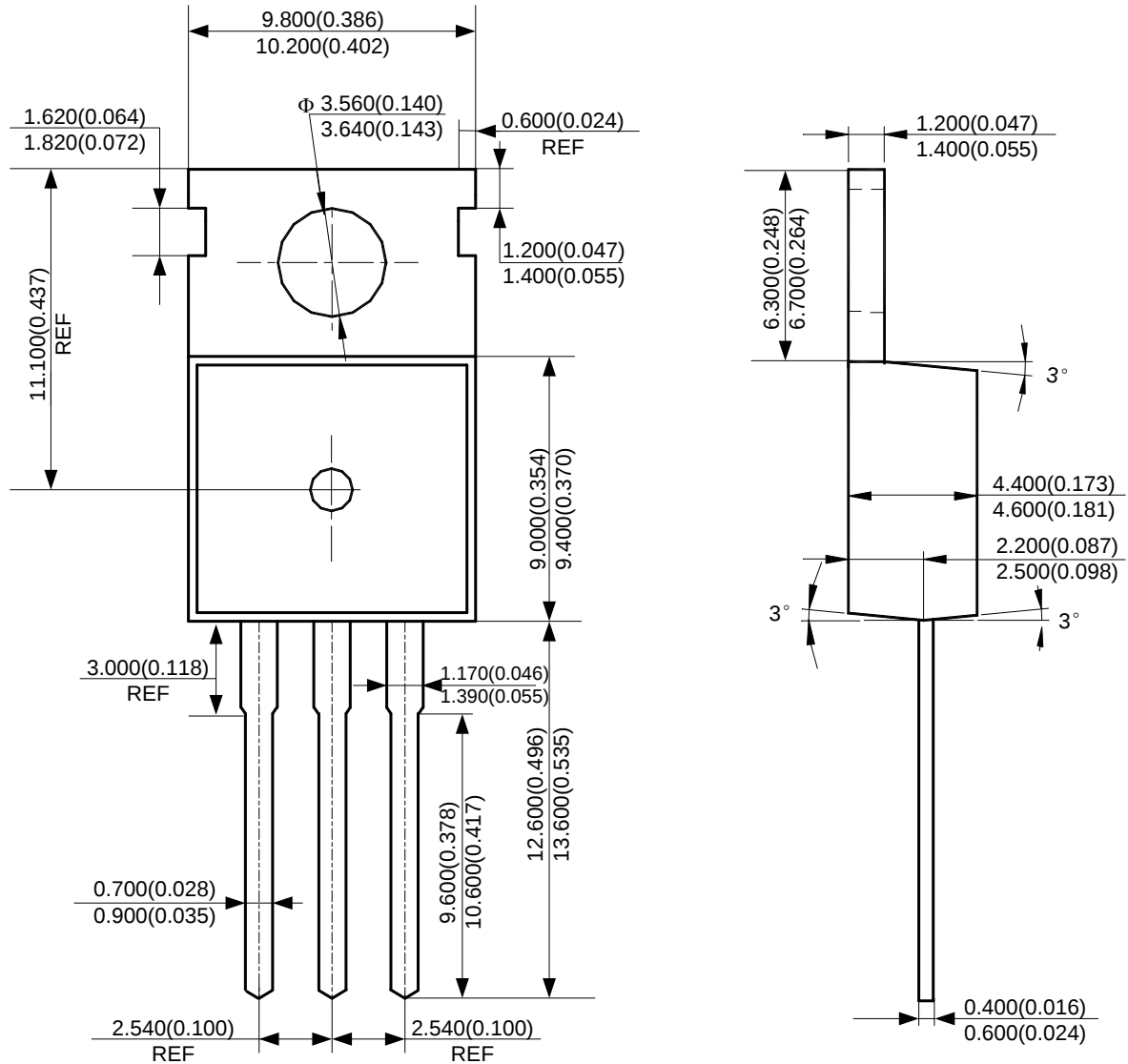


Figure 4. Average Rectified Forward Current vs. Case Temperature (Square, Each Diode)

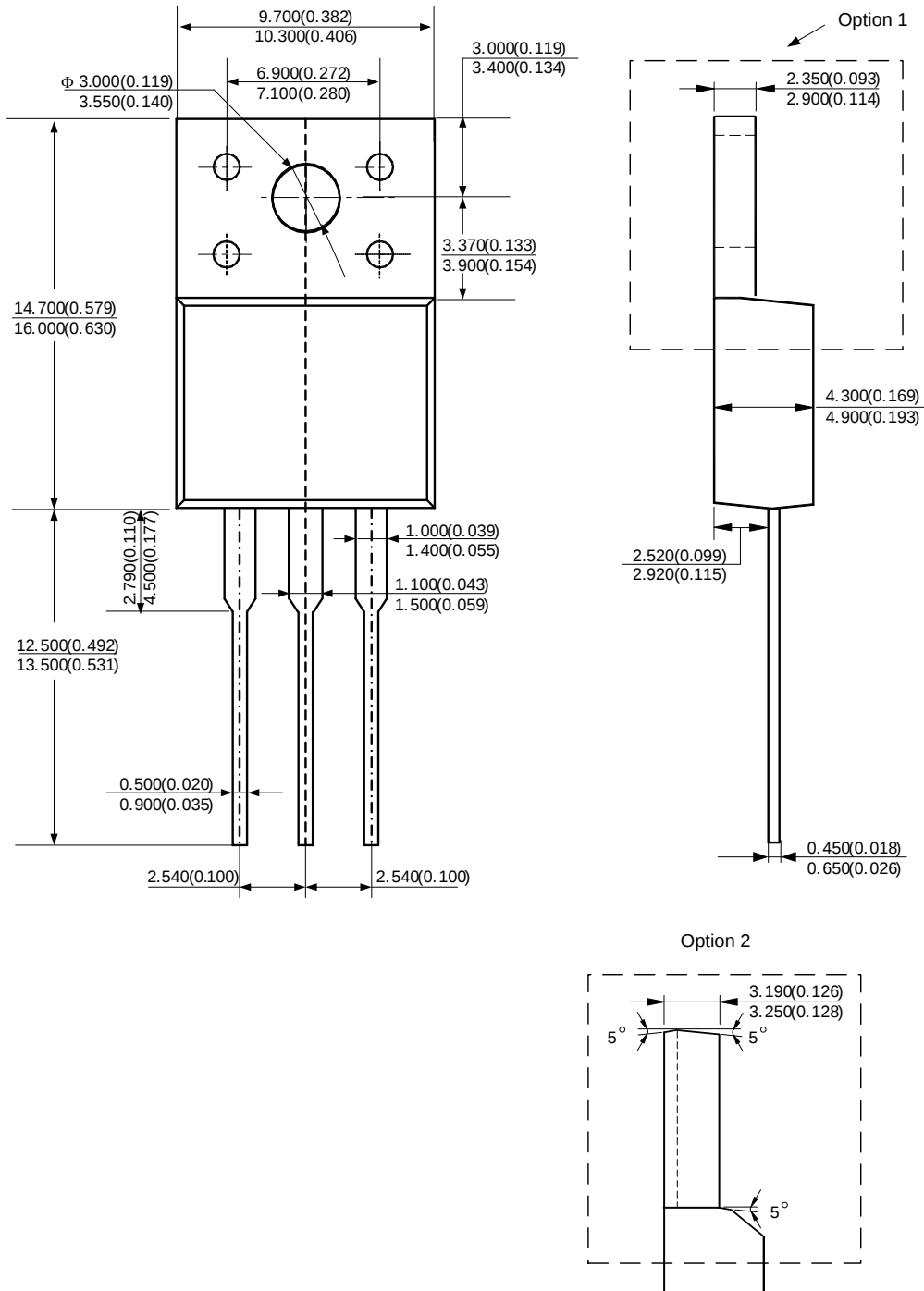
