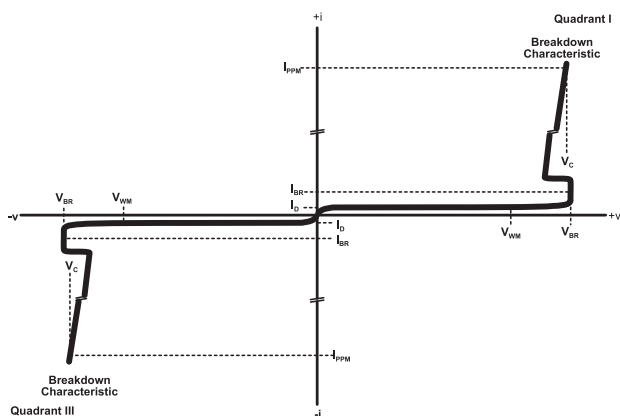

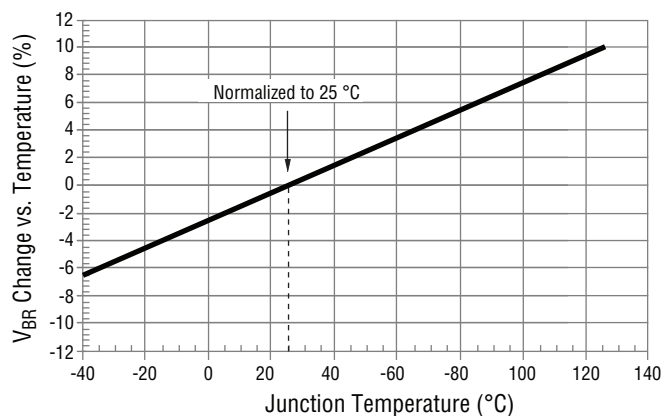

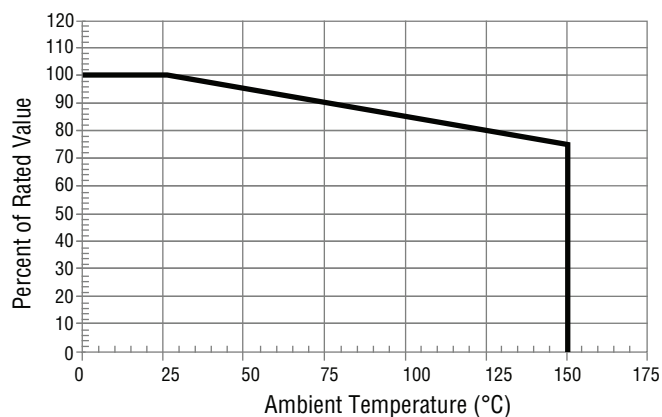
V-I Characteristic

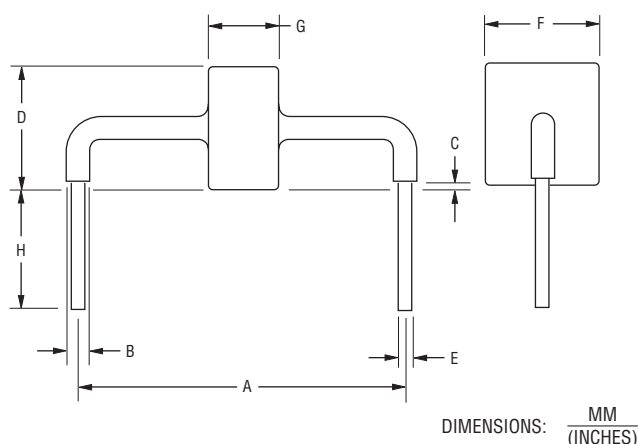

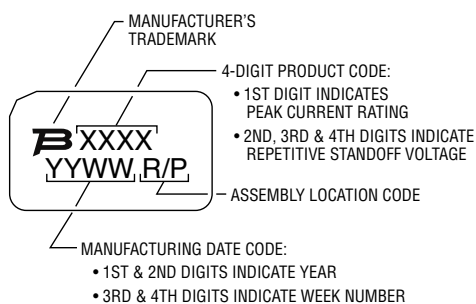

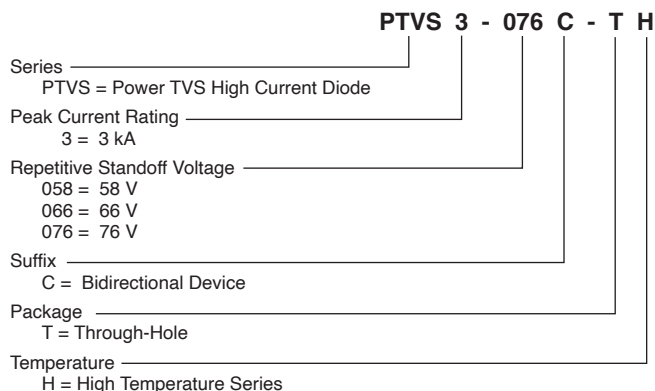
