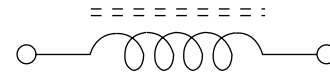
Product Dimensions

Electrical Schematic

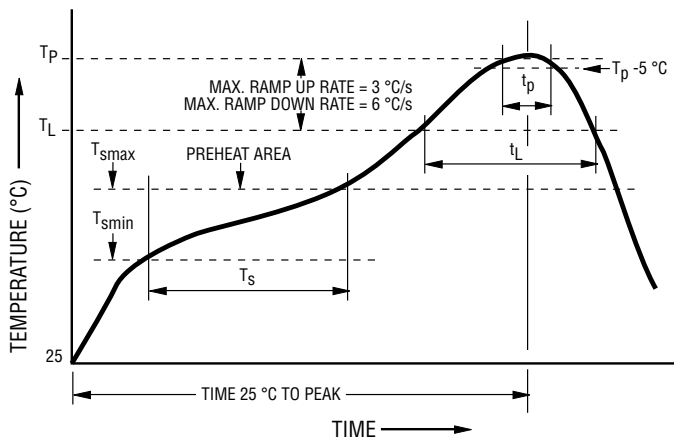

Characteristic Changes vs. IDC

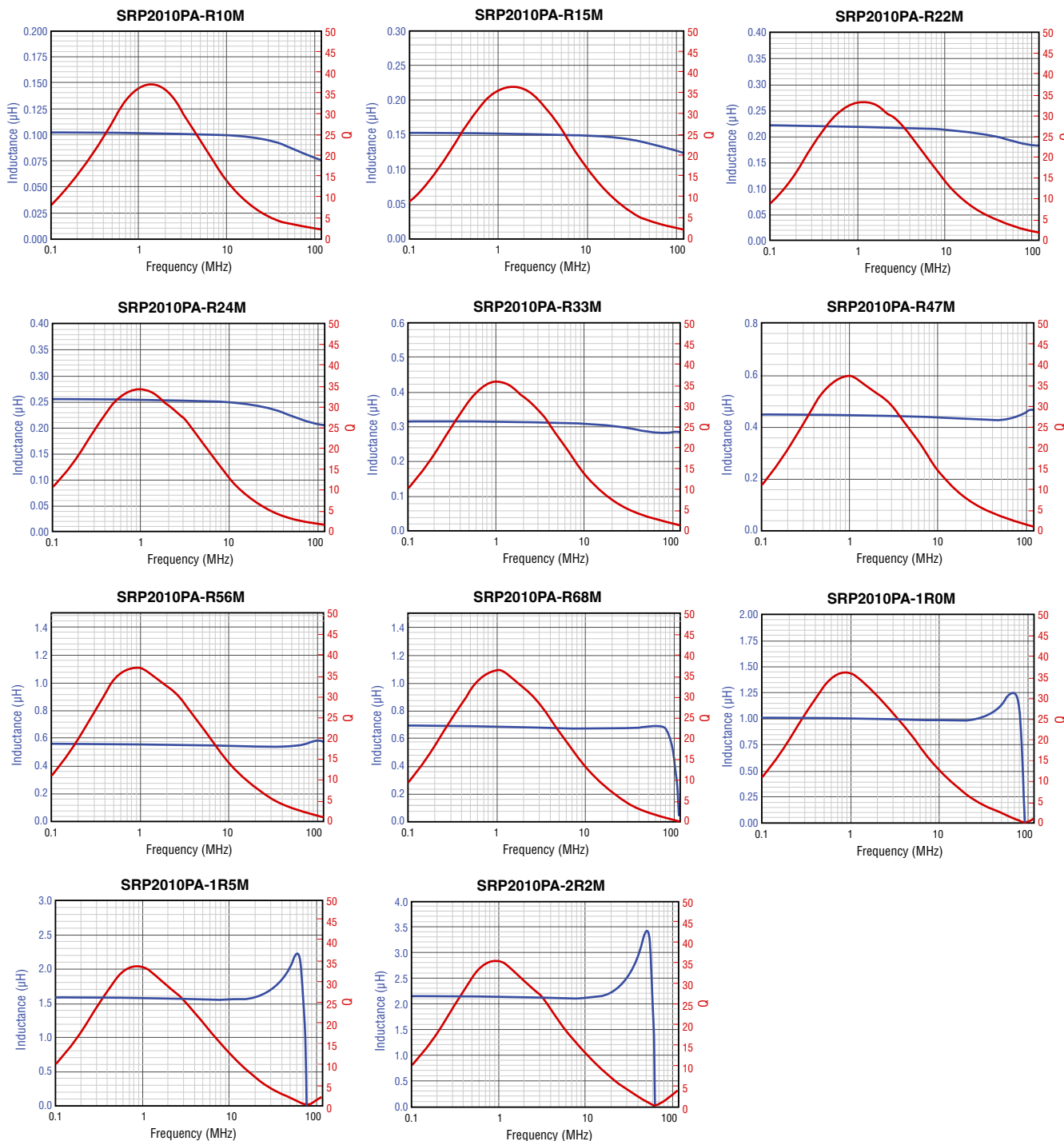

Characteristic Changes vs. Frequency

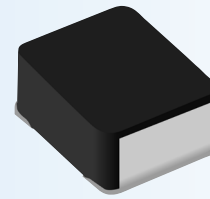

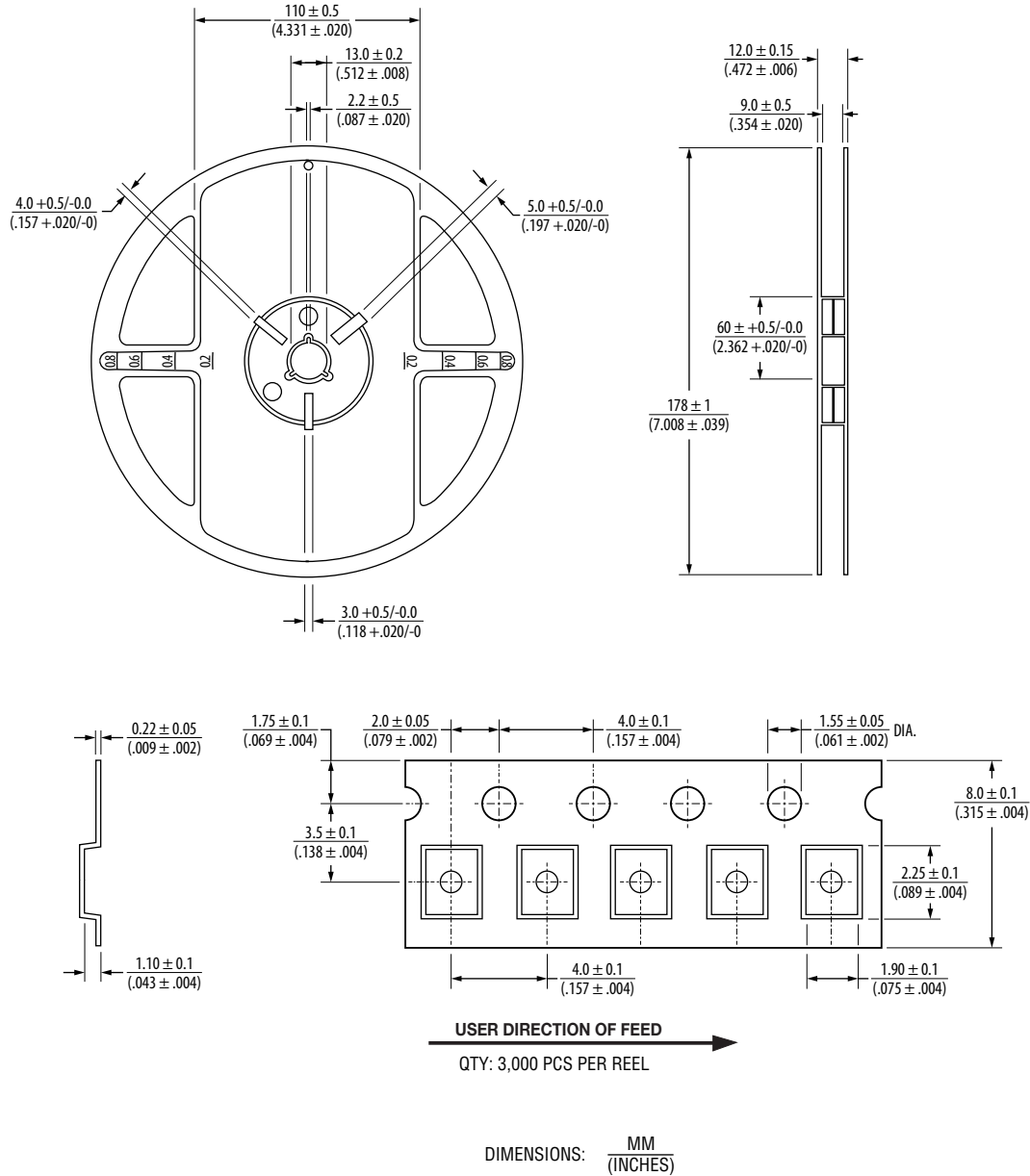
