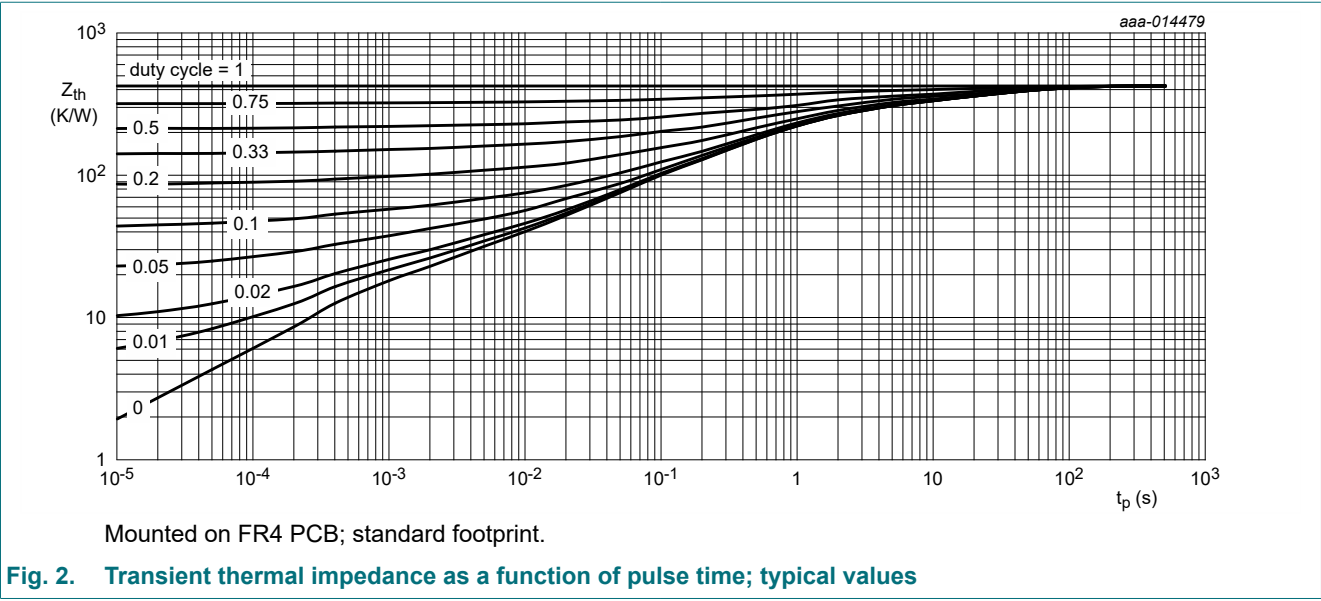

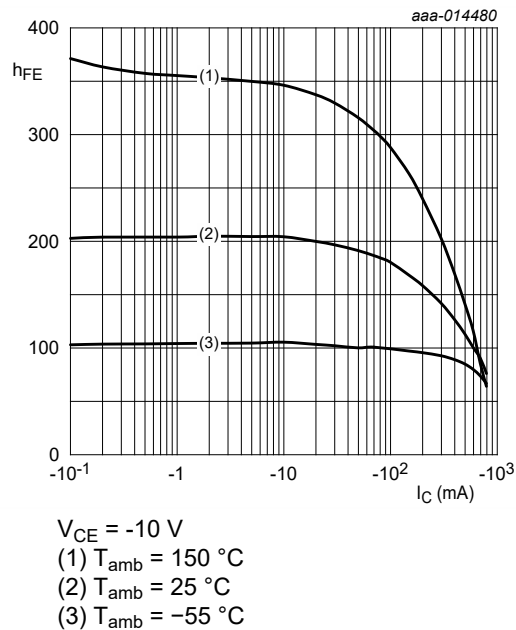


Fig. 3. DC current gain as a function of collector current; typical values

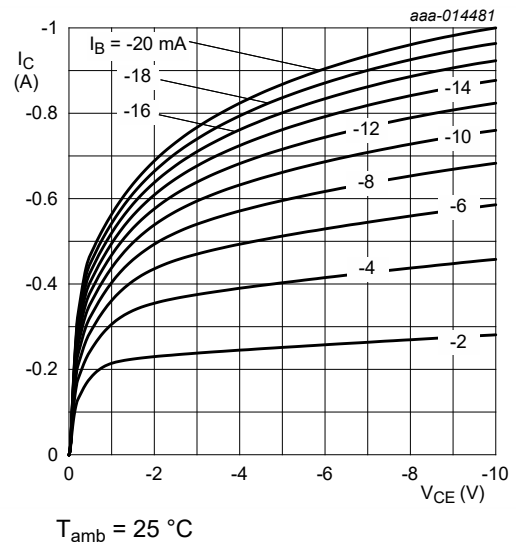


Fig. 4. Collector current as a function of collector-emitter voltage; typical values

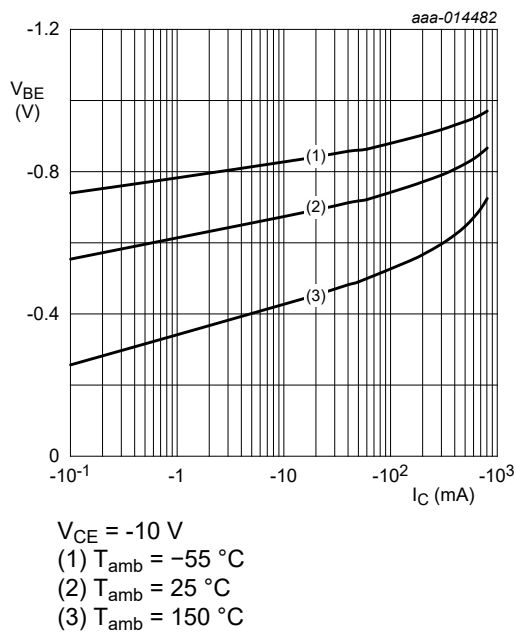


Fig. 5. Base-emitter voltage as a function of collector current; typical values

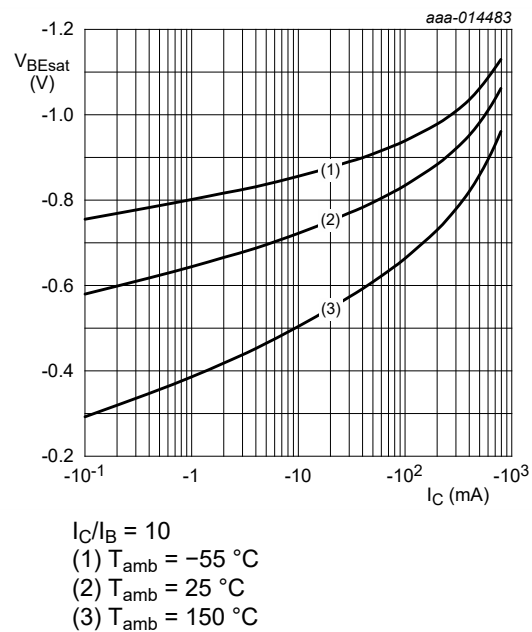
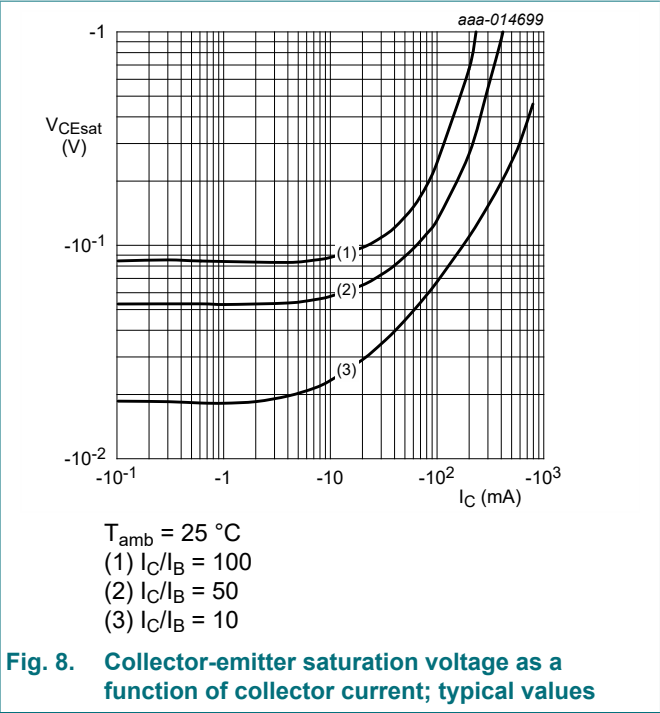
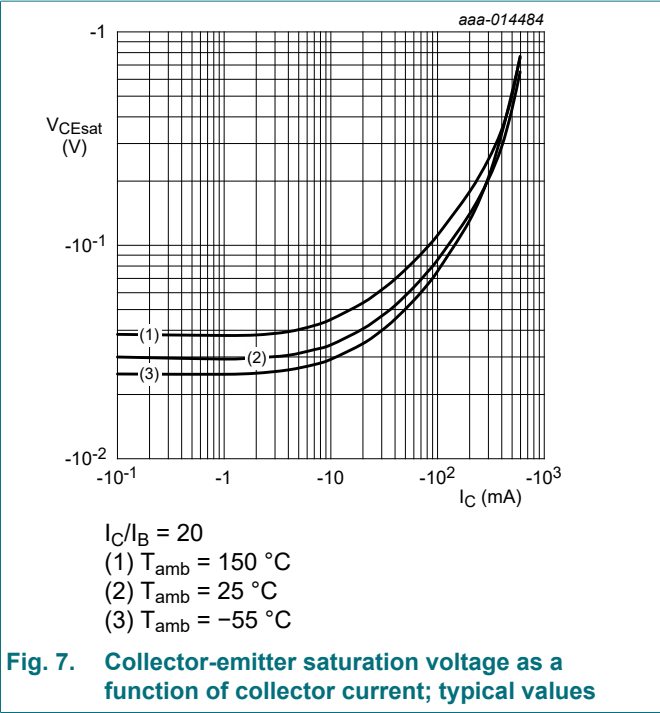
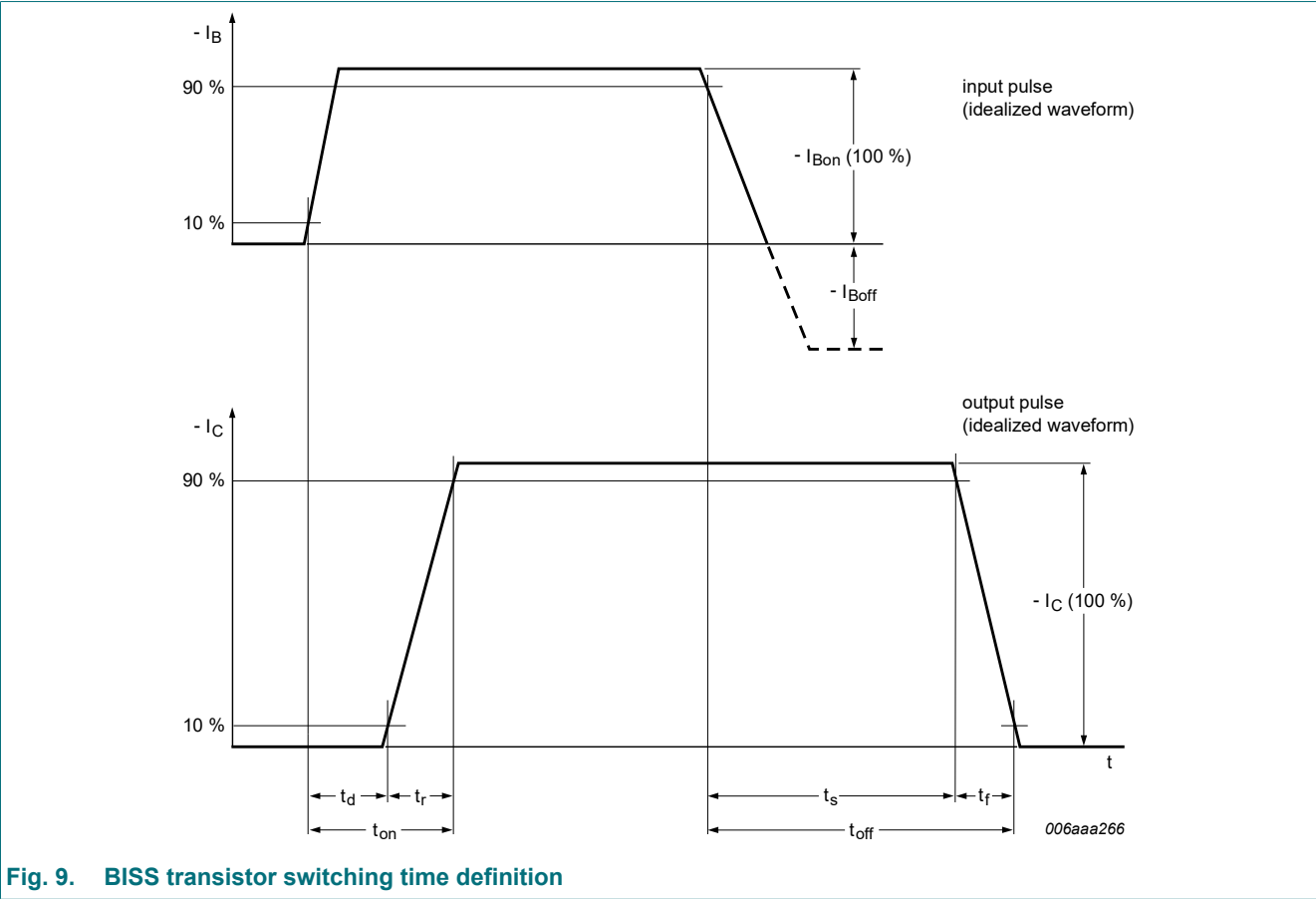


Fig. 6. Base-emitter saturation voltage as a function of collector current; typical values

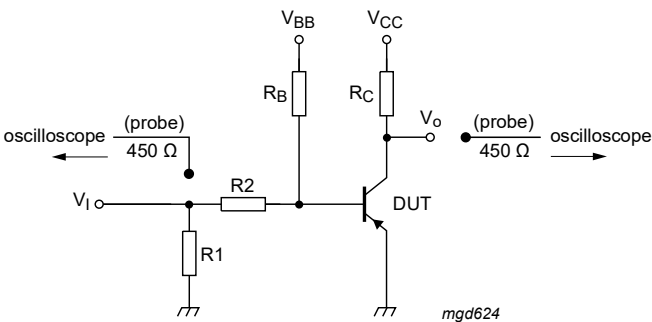


Fig. 10. Test circuit for switching times

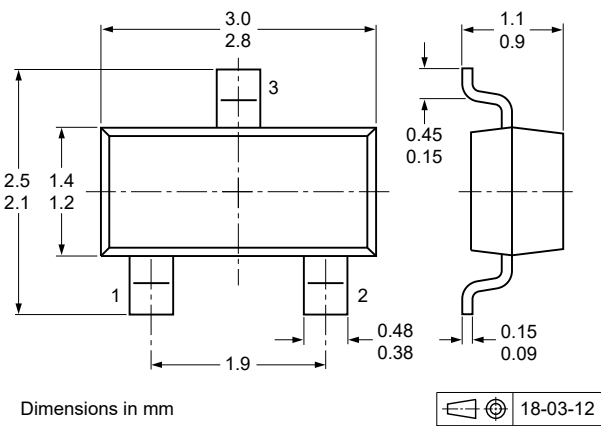


Fig. 11. Package outline SOT23

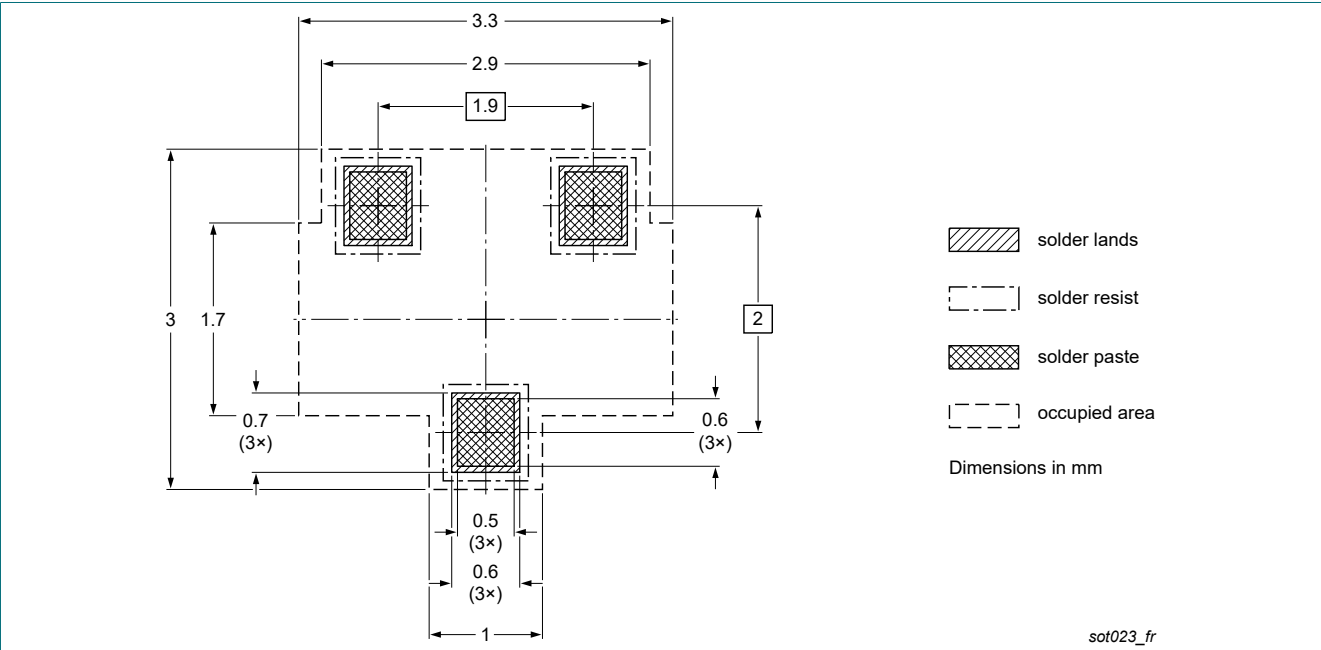


Fig. 12. Reflow soldering footprint for SOT23

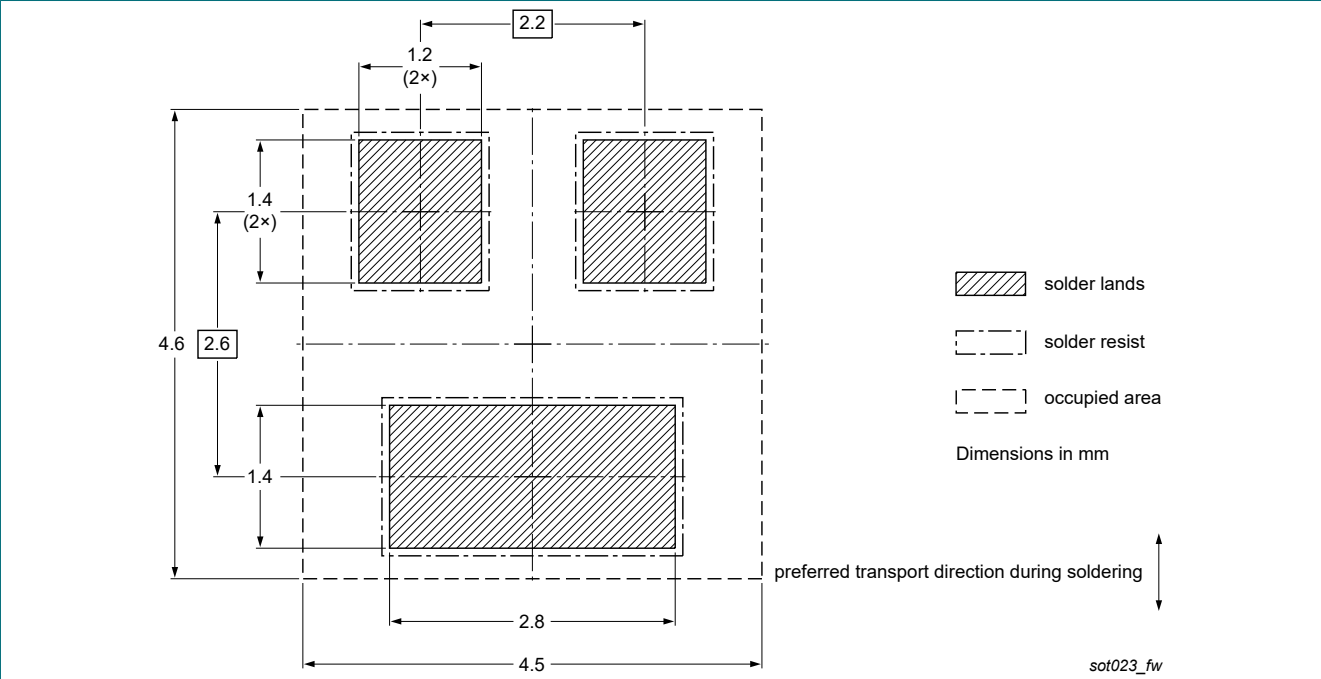


Fig. 13. Wave soldering footprint for SOT23
