

Description

The ESDZX051-1BF4 is a bidirectional single line TVS diode designed to protect the data lines or other I/O ESD transients. Thanks to extra low capacitance, ESDZX051-1BF4 can protect high speed differential lines with no impact on signal integrity.

With an extremely low clamping voltage, ESDZX051-1BF4 is able to protect the most sensitive, submicron technology circuits.












Figure 8. Harmonic measurement at 710 MHz: H2 **→** H2 710 MHz H2 ESDZX051-1BF4 -10 -20 -30 -40 Mod -50 포 -60 -70 -90 10 20 25 Input power

2 Application information

2.1 Latch-up consideration

There is a potential risk of latch-up using SCR based ESD protection if the working voltage V_{RM} is higher than V_{H} voltage.

To ensure a latch-up free state, the current injected in the protection must be lower than the holding current I_{HOLD} when the voltage across the protection device is equal to V_{HOLD} . The following equation gives the latch-up free condition.

$$I_{HOLD} > \frac{V_{SOURCE\max} - V_{HOLD}}{R_{SOURCE\min}}$$






Figure 15. Tape and reel specification (in mm)




4 Recommendation on PCB assembly

4.1 Footprint

Figure 16. Footprint in mm




Solder mask opening

4.2 Stencil opening design

- 1. Recommended design reference
 - a. Stencil opening dimensions: 75 μm / 3 mils
 - b. Stencil aperture ratio: 100%

4.3 Solder paste

- 1. Halide-free flux qualification ROL0 according to ANSI/J-STD-004.
- 2. "No clean" solder paste is recommended.
- 3. Offers a high tack force to resist component movement during high speed.
- 4. Use solder paste with fine particles: powder particle size 20-38 μm.

4.4 Placement


- 1. Manual positioning is not recommended.
- 2. It is recommended to use the lead recognition capabilities of the placement system, not the outline centering
- 3. Standard tolerance of ±0.05 mm is recommended.
- 4. 1.0 N placement force is recommended. Too much placement force can lead to squeezed out solder paste and cause solder joints to short. Too low placement force can lead to insufficient contact between package and solder paste that could cause open solder joints or badly centered packages.
- 5. To improve the package placement accuracy, a bottom side optical control should be performed with a high resolution tool.
- 6. For assembly, a perfect supporting of the PCB (all the more on flexible PCB) is recommended during solder paste printing, pick and place and reflow soldering by using optimized tools.

4.5 PCB design preference

- 1. To control the solder paste amount, the closed via is recommended instead of open vias.
- 2. The position of tracks and open vias in the solder area should be well balanced. A symmetrical layout is recommended, to avoid any tilt phenomena caused by asymmetrical solder paste due to solder flow away.

4.6 Reflow profile

Note: Minimize air convection currents in the reflow oven to avoid component movement. Maximum soldering profile corresponds to the latest IPC/JEDEC J-STD-020.

Figure 19. Ordering information scheme


