Typical Attenuation:



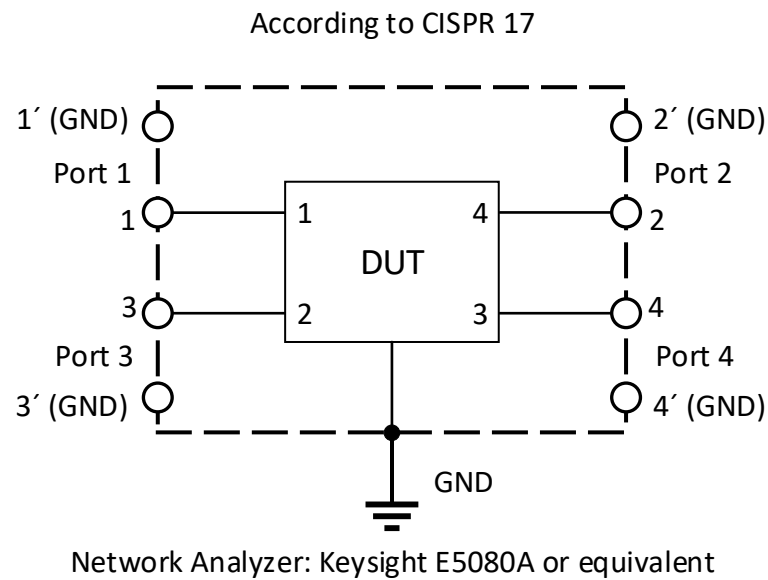
